Results will be announced at the conclusion of voting on April 26, 2021 and posted on the CTA Website within 2 working days. Candidates and/or their designated observer may view the live tally during the times that voting is open and will receive a URL address and instructions to log on to the site prior to the start of voting. Any member in good standing <u>for at least two years prior to being elected</u> may run for Delegate(s) and may nominate themselves. \*All candidates nominated must sign below certifying that they accept the nomination. In order to vote in a CTA election, an individual must be a dues-paying member in good standing for sixty (60) days prior to the election. CTA members in good standing are eligible to vote in accordance with the CTA Election and Campaign Guidelines for the Orange County CTA Delegate Nominations and Elections 2021. ## NOTICE OF ORANGE COUNTY CTA DELEGATE NOMINATIONS AND ELECTIONS 2020 ELECTION CYCLE

Note: 3 State Delegates 27 Local Delegate Positions open for a total of 30\* positions. The CTA President is an automatic Local Delegate to the NEA Representative Assembly by virtue of election to the office of CTA President.\* The top three (3) Candidates with highest votes will be designated as State Delegates. In the event that candidates are elected by acclimation, State Delegates will be determined by drawing lots. Since the NEA Representative Assembly will be held virtually in 2021, no stipends or reimbursements will be issued.

### Florida Education Association (FEA) Delegate Assembly Delegate, Orlando, Rosen Centre Hotel, October 14-16, 2021

**NOTE:** 154 Delegate Positions open. The CTA President and the two FEA Governance Board members are automatic Delegates to the FEA Representative Assembly by virtue of election. All FEA Delegates attending the Delegate Assembly may request reimbursement for up to \$80 for receipted meals, for the entire convention, in addition to reimbursement for mileage at the IRS rate, and parking (excluding valet parking). No lodging expenses will be reimbursed to FEA Delegates. One CTA Association Day will be provided to the top 20 Candidates with the highest votes, if necessary, and upon timely request. In the event that candidates are elected by acclimation, association days will be determined by drawing lots. If for any reason the Assembly moves to a virtual platform, no stipends or reimbursements will be issued.

Candidates and/or their designated observer may view the live tally during the times that voting is open and will receive a URL address and instructions to log on to the site prior to the start of voting.
